The purpose of this modification is to obligate FY'05 funds in the amount of \$10,000.00, thereby increasing the obligated amount of the contract from \$46,000.00 to \$56,000.00.

Accordingly, the contract is hereby modified as follows:

Under Subsection B.3, Consideration and Obligation-Delivery Orders, the first sentence of Paragraph (b) is deleted in its entirety and substituted with the following in lieu thereof:

"(b) The amount presently obligated with respect to this contract is \$56,000.00."
