The purpose of this modification is to:

(1) revise Subsection **A.2 CONSIDERATION AND OBLIGATION**, by increasing the total obligated amount by \$25,000.00 from \$759,992.10 to \$784,992.10.

Accordingly, the following section of the contract is hereby modified:

1. Under subsection **A.2 CONSIDERATION AND OBLIGATION** paragraph (b) is deleted entirely and the following are substituted in-lieu thereof:

"A.2. CONSIDERATION AND OBLIGATION

(b) The amount presently obligated with respect to this contract is **\$784,992.10**. The Contracting Officer may issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph (a) above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."

Note: The obligated amount shall, at no time, exceed the task order ceiling. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this task order. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

A summary of obligations under this task order, from date of the award through this modification, is given below:
