The meeting is open to the public for observation. Following the presentation, the NRC staff will be available to answer questions from you and members of the public regarding the safety performance of Susquehanna and the role of the NRC in ensuring safe plant operations.

The NRC recently completed its annual assessment of the safety performance of the Susquehanna Steam Electric Station in accordance with the NRC Reactor Oversight Process. Our assessment used the most recent performance indicator data and inspection findings from January 1, 2004 through December 31, 2004. We described our assessment results in a letter to PPL Susquehanna, LLC on March 2, 2005; A copy of that letter is enclosed.
