Senator Specter's office has referred your letter to the U.S. Nuclear Regulatory Commission (NRC) for a direct response. In your letter you raised several concerns regarding the effects of NRC's December 10, 2004, Denial of your license renewal and Order Suspending License (Effective Immediately) on your company. You also stated that you had appealed the NRC's decision, that a hearing was scheduled for early March, and that you had initiated settlement discussions with the NRC. As you know, on March 1, 2005, Safety Light, the Commonwealth of Pennsylvania, and the NRC filed a joint motion to the Atomic Safety and Licensing Board (Board) presiding in this matter, requesting that the proceeding be held in abeyance while the parties pursued settlement negotiations. On March 2, 2005, the Board granted the motion, ruling that it would hold the proceeding in abeyance for 40 days while those negotiations proceed. Because the issues raised in your letter are the subject of ongoing settlement negotiations, it would not be appropriate to comment on them outside such negotiations.
