SUBJECT: NOTICE OF DOCKETING AND ACKNOWLEDGMENT OF THE THREE MILE ISLAND 2 (TMI-2) INDEPENDENT SPENT FUEL STORAGE INSTALLATION (ISFSI) REQUEST FOR PROPOSED LICENSE AMENDMENT (TAC. NO. L23812)

Dear Ms. Sellers:

By letter dated January 31, 2005, the Department of Energy (DOE) submitted a request regarding the TMI-2 ISFSI, License No. SNM-2508. The application proposes to change the technical specification corrective actions if the 5 year leak test of the dry shielded canisters fails.

This is to inform you that the application appears to contain the necessary information to begin our technical review. The schedule below establishes the key milestones and dates associated with the application through completion of our review. Please note that the schedule allows for the staff to issue a possible request for additional information (RAI) in May 2005. If no RAI is needed, and based on the staff's evaluation, our Safety Evaluation Report and ISFSI license amendment may be issued at approximately that time.

SUPPLEMENTARY INFORMATION:

By letter dated January 31, 2005, the Department of Energy (DOE or licensee) submitted an application to the U.S. Nuclear Regulatory Commission (NRC or the Commission), in accordance with Title 10 of the Code of Federal Regulations (10 CFR) 72.56, requesting the amendment of the Three Mile Island 2 (TMI-2) Independent Spent Fuel Storage Installation (ISFSI) license for the ISFSI located in Butte County, Idaho. DOE proposes to change the technical specification corrective actions if the 5 year leak test of the dry shielded canisters fails.

This application was docketed under 10 CFR Part 72; the ISFSI Docket No. is 72-20 and will remain the same for this action. Upon approval of the Commission, the TMI-2 ISFSI license, SNM-2508, would be amended to allow this action.

The Commission may issue either a notice of hearing or a notice of proposed action and opportunity for hearing in accordance with 10 CFR 72.46(b)(1) regarding the proposed amendment or, if a determination is made that the proposed amendment does not present a genuine issue as to whether public health and safety will be significantly affected, take immediate action on the proposed amendment in accordance with 10 CFR 72.46(b)(2) and provide notice of the action taken and an opportunity for interested persons to request a hearing on whether the action should be rescinded or modified.
