**NRC and Agreement State licensees are required to make inventory and accounting reports on DOE/NRC Form 741 for certain source of special nuclear material inventory changes, for transfers or receipt of special nuclear material, or for transfer or receipt of 1 kilogram or more of source material. The use of DOE/NRC Form 740M, and 741, together with NUREG/BR-006, the instructions for completing the forms, enables NRC to collect, retrieve, and analyze as necessary, and submit the data to IAEA to fulfil its reporting responsibilities.**
