SUBJECT: WITHDRAWAL OF NOTICE OF VIOLATION DATED
FEBRUARY 14, 2005, SOUTHAMPTON MEMORIAL HOSPITAL

Dear Mr. Dardeau:

This refers to your letter dated February 14, 2005, submitted in response to our February 1, 2005 letter and the attached Notice of Violation. The violation involved your failure to apply for and receive an amendment to your NRC license before changing the areas of use for byproduct material as required by 10 CFR 35.13.

You stated in your letter that you believed the Notice of Violation was issued in error and you requested that the violation be retracted. Specifically, you stated that an amendment to your NRC license was issued to you on April 22, 2004, and that this date was before the actual relocation of your use of byproduct materials in June 2004.

After a more thorough review of our records, we determined that you had notified the NRC regarding the new facilities and an amendment was issued by the NRC prior to your change in the areas of use of licensed byproduct material. Therefore, the Notice of Violation attached to our letter dated February 1, 2005, is hereby withdrawn. Our records will be amended to reflect this change and no further response from you is required at this time.
