The purpose of this modification is to:

- (1) exercise Option Year 3 of the contract, thereby extending the term of this contract through January 31, 2006; and
- (2) provide full funding in the amount of \$576,361.20 for Option Year 3.

Accordingly, the contract is modified as follows:

1. Under Section B.4, "CONSIDERATION AND OBLIGATION-FIRM FIXED PRICE (JUN 1988)," the firm fixed price amount of the contract is increased by \$576,361.20 from \$2,178,982.80 to \$2,755,344.00. Therefore, the sentence under this section is DELETED entirely and REPLACED with the following:

"The firm fixed price of this contract is \$2,755,344.00."

3. Under Section B.5, "DURATION OF CONTRACT PERIOD," DELETE the sentences under this section entirely and REPLACE with the following:

"This contract shall commence on February 1, 2001 and will expire January 31, 2006."
