

This modification exercises the first option year under the contract which raises the contract ceiling to \$1,549,823. Accordingly, the following revision is made:

1. Section B.2, "Consideration and Obligation - Task Orders", para. (a), first sentence, is revised as follows:

"(a) The Maximum Ordering Limitation (MOL) for products and services ordered, delivered and accepted under this contract is \$1,549,823."

2. F.6, "Duration of Contract Period", first sentence, is revised as follows:

"The ordering period for this contract shall commence on the date of award and will expire on September 30, 2006."

3. Section I.5, "Indefinite Quantity", last sentence of last paragraph is revised as follows:

"The contract shall govern the Contractor's and Government's rights and obligations with respect to that order to the same extent as if the order were completed during the contract's effective period; provided, that the Contractor shall not be required to make any deliveries under this contract after one year from the expiration date of the contract."

This modification also serves as the preliminary notice required by I.6 of the contract.

All other terms and conditions of the contract remain the same.
