 The purpose of this contract modification is to exercise Option Period 4 for a period of six (6) months. Accordingly, the contract is modified as follows: In accordance with Section I.2, Option Period 4 is hereby exercised at the prices set forth in the attached OF 336. The total firm fixed price of the contract is increased by \$158,085.18 from \$888,042.65 to \$1,046,127.80. Section B.4 is changed to read, "The firm fixed price of this contract is \$1,046,127.80." Section F.2 of this contract is changed to read, "The contract shall commence on June 18, 2001 and will expire on May 17, 2005. The term of this contract may be extended at the option of the Government for an additional six (6) month option period."
 All other terms and conditions remain unchanged.
