- * If more than one intermediate persons will temporarily posses the device at the intended place of use prior to its possession by the user, the report shall include identification of each intermediate person by name, address contact, and relationship to the intended user.
- * If no transfers have been made during the reporting period, the report will so indicate.

The report will be sent to the Director Of Nuclear Materials Safety and safeguards, USNRC, Washington DC, with a copy to the appropriate NRC Regional office.
