The purpose of this modification is to provide incremental funding in the amount of \$30,885 for NRR and \$13,500 for CFO. Accordingly, the contract is hereby modified as follows:

Under Section B.2, Consideration and Obligation—Delivery Orders (JUN 1989), the first sentence of paragraph (a) is revised as follows:

“(a) The amount presently obligated with respect to this contract is \$170,302.92.”

All other terms and conditions, including the ceiling amount of \$1,397,375, remain unchanged.

A summary of obligations, from the award date through the date of this modification, are provided below:

FY 04 Obligated Amount:	\$79,413.92
FY 05 Obligated Amount:	\$90,889.00
Cumulative Obligations:	\$170,302.92

This modification obligates FY 05 funds in the amount of \$44,385.
