Dear NRC

As one of the first authors of the NRC Enforcement Policy that was first published in 1980 and a selector of the number 1600 for the NUREG, I agree that it is time to cease publication and rely on the web and Federal Register. Simplifying the name makes sense. The longer name was used because of the need to make clear that notwithstanding publication in the CFR it was a policy statement and not a regulation. I would recommend that a number be associated with the Policy Statement so that the edition of the Policy Statement being used for the particular enforcement action can be identified since the statement changes from time to time. Something like OE 2005-01 might be appropriate and the next version OE 2005-02 etc.
