ERRATA TO THE ORDER OF MARCH 18, 2005

The following corrections are hereby made to the Board's Order of March 18, 2005, directing the time for the Intervenors and Staff to file answers to the March 17, 2005, Exelon Generation Co., LLC (EGC) Motion for Summary Disposition of Contention 3.1.

On page 1 of the Order, the Board discusses summary disposition under 10 C.F.R. § 2.710, which refers to summary disposition in formal adjudications under Subpart G. The present case is an <u>informal adjudication under Subpart L</u>, and therefore, the applicable regulation is 10 C.F.R. § 2.1205. Thus, pursuant to 10 C.F.R. § 2.1205, the NRC Staff and the Intervenors, Environmental Law and Policy Center, Blue Ridge Environmental Defense League, Nuclear Energy Information Service, Nuclear Information and Resource Service, and Public Citizen have twenty (20) days to file a response (i.e. all responses are due in our offices on or before noon on April 5, 2005).

In summary dispositions motions under 10 C.F.R. § 2.1205, like in all motions where it is not stated otherwise, there is no right of reply. Should a party wish to file a reply, it must seek leave of the Board under 10 C.F.R. § 2.323(c).
