

The purpose of this modification is to (1) increase the amount obligated in the task order by \$56,550 from \$383,285.00 to \$439,835.00. Accordingly, the Task Order is modified as follows:

1. The fourth paragraph, first sentence of the basic task order, beginning with, "This task-order obligates...", as modified in Modification No. 14, is deleted and substituted with the following in lieu thereof:

"This Task Order has total obligated funds in the amount of \$439,835.00"

Note: The obligated amount shall, at not time, exceed the task order ceiling. When and if the amount(s) paid and payable to the contractor hereunder equal the obligated amount, the contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer increases the amount obligated with respect to this task order.
