

The purpose of this modification is to allot incremental funding of \$231,719 to this contract.

1. \$231,719 is hereby allotted to this contract.

2. As a result, Section B.4 is replaced with the following revised Section B.4 CONSIDERATION AND OBLIGATION - COST PLUS FIXED FEE (JUN 1988)

B.4 CONSIDERATION AND OBLIGATION--COST PLUS FIXED FEE (JUN 1988) ALTERNATE I (JUN 1991)

This clause applies only to CLINs 1, 2, 4, 5, 7, 8, 10, 11, 13, and 14.

(a) The total estimated cost to the Government for full performance of this contract is \$3,722,975, of which the sum of \$3,459,981 represents the estimated reimbursable costs, and of which \$262,994 represents the fixed fee.

(b) There shall be no adjustment in the amount of the Contractor's fixed fee by reason of differences between any estimate of cost for performance of the work under this contract and the actual cost for performance of that work.

(c) The amount currently obligated by the Government with respect to this contract is \$3,084,643. As of invoice no. 38 cost recovery in amount of \$368,400 has been applied to the cost appropriation of this contract. Therefore, the total funding obligated by the NRC and applied to the contract through cost recovery is \$3,453,043. Of this amount, the sum of \$368,400 was applied to the estimated costs thru cost recovery and \$2,840,717 represents the obligated funds earmarked for reimbursement of costs, and \$243,926 represents the funds earmarked for the fixed fee.

(d) It is estimated that the amount currently allotted will cover performance through June 30, 2005.

3. All other terms and conditions remain unchanged.
