The purpose of this modification is to: 1) Extend the period of performance of the subject contract from December 1, 2004 through December 31, 2004, to provide for services until the following contract is awarded; 2) Increase the ceiling amount of the contract by \$15,946.57 from \$234,958.60 to \$250,905.17 (for basic services); and by \$2,281.43 (\$1,081.43 for Part-time services and \$1,200.00 for overtime services) from \$21,294.00 to \$23,575.43, and 3) Increase the amount funded in the contract by \$18,228.00, from \$256,252.60 to \$274,480.60. Accordingly, the contract is hereby modified:

1) Section B, Subsection B.1, Consideration and Obligation-Firm Fixed Price (June 1988) is deleted and substituted with the following in lieu thereof:

"The firm fixed price of this contract is \$250,905.17."

2) Section B, Subsection B.2, Consideration and Obligation-Delivery Orders (June 1988), paragraph (a), first sentence beginning with "The total estimated amount . . ." is deleted and substituted with the following in lieu thereof:

"(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$23,575.43."

3) Section B, Subsection B.2, Consideration and Obligation-Delivery Orders (June 1988), paragraph (b), first sentence beginning with "The amount presently obligated . . ." is deleted and substituted with the following in lieu thereof:

"(b) The amount presently obligated with respect to this contract is \$274,480.60."

4) Section C, Subsection C.4, Duration of Contract Period (Mar 1987) is deleted and substituted with the following in lieu thereof:

"This contract shall commence on October 1, 2003 and will expire on December 31, 2004."

The following is a summary of obligations from the date of award through the date of this action:
