Re: Reply to a Notice of Violation

To Whom It May Concern:

A violation has been alleged indicating that Digirad Imaging Solutions, Inc. had provided mobile nuclear medicine service at 1647 Benning Rd and 650 Pennsylvania Ave, both of Washington, D.C. without obtaining agreements (Memoranda Of Understanding or MOU) from either site's management permitting the use of byproduct materials at their address.

While it is true that services were provided prior to obtaining an MOU, it was also determined well in advance of this inspector's visit that this situation existed and the MOU's were signed and were on file at the time of the inspection. The MOU at Benning Rd. was signed on 8/9/04 and service began on 4/19/04. The MOU at Pennsylvania Ave was signed on 6/22/04 and the service began on 2/24/04. Since these two dates of the signing of the MOU were before the inspectors visit, this should have been regarded as that of self-identified, self-corrected. The MOU's are enclosed for verification.
