In response to NUREG - 1800, the San Luis Obispo Mothers for Peace has the following comments.

It is irresponsible and illogical for the NRC to propose a generic license renewal process, since each plant has a unique history and set of unresolved issues.

The original licenses granted in the mid-1980's to PG&E to operate the two reactors at Diablo Canyon were given under conditions that have radically changed in the intervening years, and which will continue to change in unforeseeable ways. Among those conditions are the following:

1. The Hosgri Fault was thought to be one of lateral movement, but there is much evidence now that points to its being a thrust fault, capable of much greater ground motion than originally assumed possible.
2. The worst conceivable sabotage possibility involved a handful of men with machine guns, not assaults from the air on either reactors or spent fuel facilities.
3. The federal government assumed it could somehow take radioactive waste off the plant site within two years, but in fact all nuclear plants are now and will be for the foreseeable future high-level radioactive waste storage dumps.
4. Young workers training for careers in operating and maintaining nuclear plants were available in sufficient numbers, but today there is a severe shortage of trained workers available to replace the aging workforce.

These problems are only a sample of crucial, unresolved problems with enormous economic and safety implications. A release of radiation, whether caused by earthquake, terrorism, or human error would be catastrophic in terms of health and property values.
