FANP discussed the history of the fluence and uncertainty methodology, how it was developed over the years, and what they will be requesting in the upcoming revision 2. Specifically, they reviewed the additional information and data which will be submitted to the NRC in March 2005. The presentation was followed by questions and answers with the NRC staff. It was determined based on the information presented in the meeting, that the NRC staff will not be able to issue an unconditional safety evaluation for generic use.
