SUBJECT: STATUS OF SITE IN NEW HAVEN, CT PREVIOUSLY LICENSED BY U.S. NRC

Dear Mr. Goldberg:

This letter refers to your telephone request to me concerning the radiological status of facilities that were previously licensed by the U.S. Nuclear Regulatory Commission at 91 and 71 Shelton Avenue, New Haven, CT. These sites were inspected in 1996, as part of a program initiated by NRC to ensure that licensed facilities that were terminated by NRC in the period from 1965 to 1985 had been terminated in accordance with the NRC's criteria for release for unrestricted use. The 1996 inspection at 91 Shelton Avenue (Enclosure 1) contains a brief history of the licensed activities that were terminated in 1976, and concludes that 91 Shelton Avenue was suitable for unrestricted use. A similar inspection was conducted at 71 Shelton Avenue, however, additional actions were required at 71 Shelton Avenue, because of some below grade soil contamination. UNC Naval Products conducted a characterization survey and completed some soil remediation in the Fall of 2003 at 71 Shelton Avenue. NRC requested by letter dated April 11, 2005 (Enclosure 2) that a final characterization plan and remediation schedule, if applicable, be provided to the U.S. NRC within the next two months from UNC Naval Products.
