After review of the document entitled, "Nuclear Regulatory Commission 10 CFR 73, RIN: 3150 AH-57, Protection of Safeguards Information", we have this to offer:

Even though the proposed rule may be broadened to cover Agreement State/Washington licensee inspection reports and other reports detailing Agreement State/Washington licensee activities; the proposed broadened control appears only to affect information regarding the unauthorized disclosure of a licensee's or applicant's detailed procedures or security measures for the physical protection of source, byproduct and special nuclear material. With this in mind, Washington State would like to suggest that the definition of "quantities determined by the Commission to be significant" be kept within reason.
