Our sole remaining site is Lackawanna Medical Group, P.C., 201 Smallacombe Drive, Scranton, PA 18508.

In addition, we request that John C. Ramsey, Medical Physicist, replace Burton Marks, D.O. as Radiation Safety Officer. Mr. Ramsey was RSO under our previous corporation and NRC license, Advanced Medical Imaging Inc., License No. 37-30690-01.

Also, we request that Richard E. Gratz, M.D. and Frank A. Milani, M.D. replace Dr. Marks as authorized users.

Our Scranton site is staffed by the same nuclear medicine technologist, and will be following the same radiation protection plan previously submitted in our original application. Bio-Med Associates, Inc., 4 Main Street, Flemington, NJ 08822, consulting medical radiation health physicists, shall assist us with safe, compliant operations by providing measurements, inventories, leak tests, audits, and reviews quarterly on-site.
