I have a few questions regarding the documentation on the final status survey results for the Elan Operations facility in Princeton, NJ you submitted to the NRC dated February 26, 2005. In order to continue my review I need the following additional information:

- 1. Please provide the total square footage of the Elan Operations, Inc. facility in Princeton, New Jersey that you surveyed in September through December 2004.
- 2. In Volume 1 of the Final Status Survey you state, "A summary of survey procedures and release criteria was previously submitted in the Decommissioning Plan dated July 2003." Section 9.0 Release Criteria of the DP states, "Because of the high DCGLw values that were determined and the objective of the survey, the actual release limits adopted by Elan will be much lower than the DCGLw values reported." Please provide the release limits used for your final status surveys.
- 3. Please provide the reference for the minimum detectable activity (MDA)equation used in the Final Status Survey, Volume 1, Survey Methodology section.
- 4. Please provide the date Elan ceased operations with licensed material at the Princeton facility. The Final Status Survey report states, "Elan has ceased all operations at the site since mid 2003." and further on, "Research activities at the Princeton site ceased early in 2003." Please clarify.
