ENVIRONMENTAL ASSESSMENT RELATED TO ISSUANCE OF A LICENSE

AMENDMENT TO BYPRODUCT MATERIAL LICENSE NO. 21-00182-03

FOR THE PHARMACIA & UPJOHN COMPANY, KALAMAZOO, MICHIGAN

Introduction

The U.S. Nuclear Regulatory Commission (NRC) staff has prepared this environmental assessment (EA) to support Pharmacia & Upjohn's (the licensee) January 26, 2005 request to release Buildings 18, 25, 126, and 209 at the Henrietta Street site, and Building 258 at 526 Jasper Street, for unrestricted use. Both sites are located in Kalamazoo, Michigan. On April 24, 1958, the Atomic Energy Commission authorized the licensee to conduct the radiological operations. The primary radioactive materials used at the Henrietta Street and Jasper Street facilities were H-3, C-14, P-32, P-33, S-35, and I-125. The EA has been developed in accordance with the requirements of 10 CFR Part 51. Based on the EA, the NRC has concluded that a Finding of No Significant Impact (FONSI) is appropriate for the proposed licensing action.

Proposed Action

The proposed action is to amend Byproduct Material License No. 21-00182-03 issued to Pharmacia & Upjohn Company, and release its Henrietta Street and Jasper Street facilities for unrestricted use. Specifically, the licensee has requested that Buildings 18, 25, 126, and 209 at the Henrietta Street site, and Building 258 at 526 Jasper Street be released for unrestricted use. The licensee conducted surveys of the facilities and provided information to the NRC to demonstrate that the site meets the radiological criteria for license termination in 10 CFR Part 20, Subpart E for unrestricted release.

Need for the Proposed Action

Pharmacia & Upjohn Company is requesting this license amendment because it no longer plans to conduct NRC-licensed activities at the Henrietta Street and Jasper Street facilities. The NRC is fulfilling its responsibilities under the Atomic Energy Act to make a decision on the proposed license amendment for decommissioning that ensures that residual radioactivity is reduced to a level that is protective of the public health and safety and the environment, and allows the Henrietta Street and Jasper Street facilities to be released for unrestricted use.

Environmental Impacts of the Proposed Action

The NRC staff has reviewed the surveys performed by Pharmacia & Upjohn Company, which the licensee provided to demonstrate compliance with the license termination criteria in Subpart E of 10 CFR Part 20.1402, "Radiological Criteria for Unrestricted Use." Based on its review, the staff has determined that the affected environment and the environmental impacts associated with the decommissioning of the Henrietta Street and Jasper Street facilities are bounded by the impacts evaluated by the "Generic Environmental Impact Statement in Support of Rulemaking on Radiological Criteria for License Termination of NRC-Licensed Nuclear Facilities" (NUREG-1496). No outdoor areas were affected by the use of licensed materials. Additionally, no non-radiological or cumulative impacts were identified.

Alternatives to the Proposed Action

The only alternative to the proposed action of allowing decommissioning of the site is no action. Under the no-action alternative, the Henrietta Street and Jasper Street facilities would remain under an NRC license and would not be released for unrestricted use. Denial of the license amendment request would result in no change to current conditions at the facility. The no-action alternative is not acceptable because it would result in violation of NRC's Timeliness Rule (10 CFR Part 30.36), which requires licensees to decommission their facilities when

licensed activities cease. This alternative would also impose an unnecessary regulatory burden and limit potential benefits from future uses of the facilities.

Agencies and Persons Consulted

This EA was prepared by Peter J. Lee, Ph.D., CHP, Health Physicist, Decommissioning Branch, Division of Nuclear Materials Safety (DNMS), Region III (RIII). The NRC staff have determined that Section 7 consultation under the Endangered Species Act is not required as the proposed action does not have the potential to affect the physical environment and, therefore, will not affect listed or proposed endangered species. Additionally, the proposed action is not the type of activity that has the potential to affect historic properties; therefore, no additional consultation under Section 106 of the National Historic Preservation Act is required. The NRC provided a draft of its Environmental Assessment (EA) to Mr. Bob Skowronek, Chief, Radioactive Material and Medical Waste Unit, State of Michigan, for review on March 23, 2005. The NRC staff addressed an April 13, 2005 comment from the State of Michigan regarding the licensee's final status survey.

Conclusion

The NRC staff concluded that the proposed action complies with the license termination criteria in Subpart E of 10 CFR Part 20 for unrestricted release. Based on its review, the staff has determined that the affected environment and the environmental impacts associated with the decommissioning and release for unrestricted use of the Henrietta Street and Jasper Street facilities are bounded by the impacts evaluated by the "Generic Environmental Impact Statement in Support of Rulemaking on Radiological Criteria for License Termination of NRC-Licensed Nuclear Facilities," (NUREG-1496). Additionally, no non-radiological or cumulative impacts were identified. Therefore, the NRC has concluded that the proposed action will not have a significant effect on the quality of the human environment and has determined that an environmental impact statement for the proposed action is not necessary.
