I am responding to your April 4, 2005, request (addressed to Thomas Smith, Chief, Public Documents Room) that the U.S. Nuclear Regulatory Commission (NRC) update and reinstate NUREG-1460, "Guide to NRC Reporting and Recordkeeping Requirements." While we agree this NUREG has been useful to both the NRC and its licensees, we cannot grant your request at this time. The Office of Management and Budget (OMB) is designing a Web-based information collections system in which it will require all Federal agencies to enter their information collections data. The data that OMB requires includes the data needed to generate and maintain the NUREG. OMB expects to deploy its system by September 30, 2006. It would require considerably more time to upgrade our outmoded system to generate the report. Therefore, we have decided not to update our system, but to wait until OMB deploys its system and then use it to generate the updated NUREG. We also plan to make the updated NUREG available electronically and to provide real-time updates in the future.
