Per our discussion today, attached are our preliminary comments on NEI's working draft of NEI 04-02 as well as the current version of the working draft of the NFPA 805 reg guide. I am forwarding these documents to you to facilitate the completion of the final versions of both documents and to assist in coordinating the content so that unnecessary duplication does not occur.

Note that the comments on NEI 04-02 are, at this stage, the personal opinions of the reviewers and not necessarily the final NRC position. Likewise, the text of the draft final reg guide is preliminary and has not been reviewed or approved by NRC management.
