

The purpose of this modification is to provide incremental funding in the amount of \$35,486.

Accordingly, the following section of the contract is hereby modified:

Under Subsection A.2 CONSIDERATION AND OBLIGATION, the obligated amount is increased by \$35,486 from \$3,099,758.43 to \$3,135,244.43. Therefore, the first sentence of paragraph (b) is deleted entirely and the following is substituted in-lieu thereof:

"(b) The amount presently obligated with respect to this contract is \$3,135,244.43."
