Dear Ms. McCalip:

As we discussed on the telephone today, Friday April 1, 2005, I will retain license condition # 12 in your current license in your renewed license. This condition limits your possession limits for certain long lived radionuclides so that financial assurance for decommissioning purposes is not required.

For Item 10 of the renewal application, please refer to section 8.10.6 "SAFE USE OF RADIONUCLIDES AND EMERGENCY PROCEDURES" on pages 8-37 through 8-39 and Appendix C, Item no. 10 on page C-10 of NUREG-1556, Volume 11. Note the "Response from Applicant" section on page 8-39. You are requested to submit your procedures for safe use of radionuclides and emergencies. Your submission should include procedures for maintaining security of licensed radioactive materials. As an alternative, you may state "We will adopt the procedures for the safe use of radionuclides and emergencies as published in Appendix R of NUREG-1556, Volume 11,...".

Your renewal application did not include the requested procedures or the standard language adopting Appendix R. Please either submit the requested procedures or a letter adopting the Appendix R procedures.
