This letter refers to the safety inspection which began on July 7, 2003, at your facility located in Burbank, California. The inspection was an examination of activities conducted as they relate to safety and compliance with the Commission's rules and regulations. Within these areas, the inspection consisted of selective examination of procedures and representative records. A final telephonic exit briefing was conducted with Mr. Marshall Bissett of your staff on April 14, 2005, and with you on April 26, 2005.

As discussed with you during the exit briefing, distribution of byproduct material to persons exempt from regulatory authority can only be made by persons who have a specific license from the Commission authorizing such distribution to persons exempt from the requirements for an NRC or Agreement State license.

Within the scope of the inspection, no violations or deviations were identified: therefore, no response to this letter is required.
