As Ray pointed out, some plant's are symptom-based and as Gareth pointed out, this does make our job harder. Alan and I planned to let the panel address this, since plants are taking "credit" for such FMAs. It might be argued that as long they can demonstrate that there will be substantial indications that the response action is needed, e.g., go locally open relevant valves if having problems, and they can meet all of the other rule "criteria," then one could argue that they should be allowed to measure time from when the indications occur. It does make sense that a time margin might have to account for potential delays in diagnosis, but this may not be all that different from the event-based actions, which could also be delayed for various reasons. I am not sure that I necessarily buy the above argument, but based on the reviews we did, quite a few plants do use these kinds of actions and they are not totally "off the wall."
