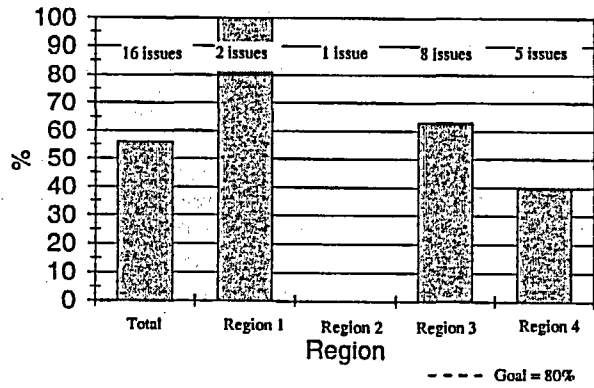

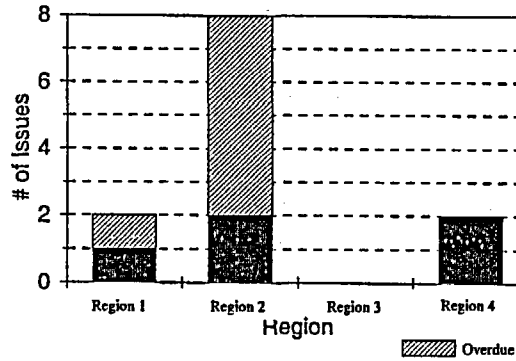

Completed Issues By Region

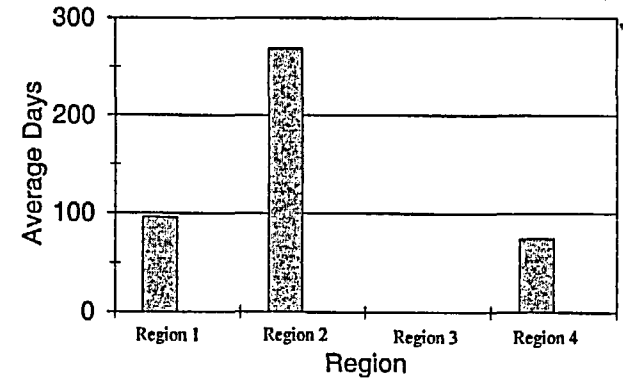


### # of Open SDP Issues
