I have completed a preliminary review of your application and have a few questions as follows:

1. Do you want the authorization for disassembly for Subitems 6.A. and 6.B. both ?

Response 5/9/05: No sir, good point. We would only be disassembling 6.A.

2. Is the training received by both proposed authorized user candidates that which you committed to provide in your July 17, 2004 letter?

Response 5/9/05: Yes, all radiation area workers receive the same training, provided by me. Our radiation safety committee also includes Floyd Johnson who is a certified RSO as well. We review the training program.

3. I note that you have indicated your March 25, 1994 application that you have fire suppression equipment , however, in the event that a problem occurs in burning the tracer what provisions do you have for bioassay of individuals who could be exposed to airborne activity?

Response 5/9/05: Our Radiation Safety Plan includes testing nasal swabs and urinalysis. I intend to ensure that we never do anything that will make that necessary, but that is what we would do. We conducted the test described in the report sent with the amendment request to prove the DU rod would not be significantly warmed during the tracer burn.
