

Item 10. RADIATION SAFETY PROGRAM – SURVEY INSTRUMENTS

We possess and use a radiation survey meter (TroxAlert – manufactured by Troxler Electronic Laboratories, Inc.) for use in the event of an accident involving a gauge. The survey meter will be calibrated annually by the manufacturer and checked for functionality before each use.

Physical inventories will be conducted at intervals not to exceed 6 months, to account for all sealed sources and devices received and possessed under the license.
