TRANSMITTAL OF THE OFFICE OF CIVILIAN RADIOACTIVE WASTE MANAGEMENT (OCRWM), OFFICE OF REPOSITORY DEVELOPMENT, AND THE MANAGEMENT AND OPERATING CONTRACTOR (M&O) ORGANIZATION CHARTS

Reference: Ltr, Ziegler to Director, High-Level Waste Repository Safety (NRC), dtd 4/11/05 (Transmittal of OCRWM QARD, DOE/RW-0333P, Revision 17, Additional Information Needs [AIN])

The U.S. Department of Energy agreed to provide the U.S. Nuclear Regulatory Commission (NRC) with the OCRWM and principal contractor organization charts to assist NRC in their review of the Quality Assurance Requirements and Description (QARD), Revision 17, and our response to AIN-1. Revisions to Project organization charts to reflect QARD, Revision 17, Section 1.3, requirements will be completed before the effective date of Revision 17.

The OCRWM organization chart was extracted from LP-1.1Q-OCRWM Revision 1, ICN 2, entitled "Organization." A few items to note regarding this chart: The Office of Strategy and Program Development (OSPD) provides support for Yucca Mountain Project (YMP)-related activities. For those YMP-related activities, OSPD is subject to the requirements of the QARD. The Office of Science and Technology and International and the Office of National Transportation currently perform no QARD activities. The Office of Repository Development has a contractual relationship with the M&O contractor, currently Bechtel SAIC Company, LLC (BSC), which flows down quality requirements through the contract.

The BSC organization chart was extracted from LP-1.0Q-BSC Revision 4, ICN 1, entitled "Organization." We have also provided a more detailed BSC organizational chart approved by the BSC General Manager.

This letter transmits these organization charts for your use.






