Richard:

In response to your phone conversation with Terry Brock of my staff today, I am confirming NRC's responsibility to concur on the license termination of uranium milling licenses in Agreement States, including in situ leach facilities. The implementing procedure for this responsibility can be found in the NRC's Office of State and Tribal Programs procedure SA-900: Termination of Uranium Milling Licenses in Agreement States (link below). This procedure describes the NRC review process for making the determination that all applicable standards and requirements have been met prior to Agreement State uranium milling license termination, as required by 10 CFR 150.15a(a) and Section 274c of the Atomic Energy Act of 1954, as amended.
