Pursuant to the Atomic Safety and Licensing Board's ("Licensing Board") Initial Scheduling Order,¹ the staff of the Nuclear Regulatory Commission ("Staff") herein submits its third status report regarding the review schedule for the extended power uprate ("EPU") application that is at issue in this proceeding.

The Staff is continuing to review recent supplements to the EPU application, and expects to issue further requests for additional information ("RAIs") in the near future. In addition, the Staff is currently re-assessing the schedule, including coordinating with the Advisory Committee on Reactor Safeguards ("ACRS") to establish dates for the ACRS subcommittee and full committee meetings. Pursuant to the Initial Hearing Order, the Staff will submit an updated status report on or about June 15, 2005.
