REQUEST FOR NUCLEAR REGULATORY COMMISSION (NRC) REVIEW OF BASIS FOR EXCEPTION TO THE HANFORD FEDERAL FACILITY AGREEMENT AND CONSENT ORDER RETRIEVAL CRITERIA FOR SINGLE-SHELL TANK (SST) 241-C-106

Reference: ORP letter from R. J. Schepens to J. R. Strosnider, NRC, "Interagency Agreement Between the U.S. Department of Energy (DOE), Office of River Protection (ORP) and the Nuclear Regulatory Commission (NRC) for Management of Tank Waste at the Hanford Site, "04-TPD-085, dated August 20, 2004.

Attached for your review are four copies of the "Basis for Exception to the Hanford Federal Facility Agreement and Consent Order Retrieval Criteria for Single-Shell Tank 241-C-106" (RPP-20658, Revision 1). Also attached are four copies each of "Stage I Retrieval Data Report for Single-Shell Tank 241-C-106" (RPP-20110, Revision 2) and "Stage II Retrieval Data Report for Single-Shell Tank 241-C-106" (RPP-20577, Revision 0), which provide data in support of RPP-20658.

These documents provide the technical basis for the U.S. Department of Energy, Office of River Protection (ORP) determination that retrieval of Tank C-106 is complete based on the decision-making process and criteria presented to you on September 28, 2004. In accordance with the Reference (Attachment 2, Statement of Work, Section 2), ORP is seeking NRC technical review of its retrieval completion process and the analysis for determining radiological sufficiency of retrieval for Tank C-106.

Please note that ORP is currently developing other documents that will be provided for your review in the near future, including an SST waste retrieval process document and an SST system performance assessment. These documents are expected to be ready for NRC review in October 2004 and January 2005, respectively. Other supporting documents and information will be provided upon your request.
