#### FIRST AMENDMENT TO TRUST AGREEMENT

WHEREAS, the University of Vermont and State Agricultural College (University) and the Chittenden Trust Company (Trustee) have entered into a Trust Agreement dated February 1, 1994, for the purpose of providing financial assurance to the U.S. Nuclear Regulatory Commission (NRC); and

WHEREAS, changes in NRC regulations have resulted in the requirement that an increased amount of funds be set aside for the purposes of the Trust Agreement;

NOW, THEREFORE, the University and the Trustee hereby agree:

- 1. Schedules A and B of the Trust Agreement are hereby superseded and replaced with Schedules A and B attached hereto.
- 2. In all other respects the Trust Agreement remains in full force and effect.
