Renewal of Material License

Dear Ms. Modes:

In response to your January 31, 2005<sup>1</sup> request for additional information for our pending renewal of this material license, we offer the following information:

The current cost to decommission this license is estimated to be zero dollars. This license is rarely invoked outside of our facility and was last used to modify a steam generator for shipment to a burial facility at a rail head in Portland, CT. The railhead was surveyed after the repair and found to be free of any licensed material.

In order to cover the potential future expense of any remediation and cleanup if this material license is invoked again at an unlicensed offsite facility that requires remediation and surveys, we have increased the funds in the escrow account covered in the current escrow agreement to \$10,000 (See attached). Since there are no decommissioning costs associated with this license, there is no need to submit a decommissioning funding plan. Therefore, please consider this letter as an exemption request to exempt CYAPCO from the requirements of 10 CFR 30.35(a), if deemed necessary. Note that the material license is not used at the Haddam Neck Plant which is covered under NRC License DPR-61.

Your letter of January 31, 2005 also requested a signed copy of a certified resolution authorizing the making and performance of the escrow agreement.



He is also the Radiation Protection Manager for License DPR-61. Please include this change in the renewal.
