

6. Leak tests and inspections were last performed on November 23, 2004, and will be conducted in accordance with the applicable permit schedule in the future.
7. All applicable records, including those addressing the safe operation and decommissioning of the nuclear sources currently licensed under the above referenced license, will remain at the plant site and have been transferred to the control of SWVR.
8. SWVR will abide by all constraints, conditions, requirements and commitments of the above referenced license.
