SUBJECT: INTEGRATED MATERIALS PERFORMANCE EVALUATION
PROGRAM (IMPEP) REVIEW OF REGION I RADIATION
CONTROL PROGRAM

This memorandum transmits to the Management Review Board (MRB) a proposed final report (Attachment 1) documenting the IMPEP review of the Region I (RI) Radiation Control Program. The review of the RI program was conducted by an interoffice team during the period of April 4-8, 2005. The team issued a draft report to RI on April 27, 2005, for factual comment. RI sent factual comments by memorandum dated May 13, 2002 from George Pangburn, (Attachment 2), which have been incorporated into Attachment 1.

The review team found RI's performance with respect to each of the performance indicators to be satisfactory. Accordingly, the team recommends that the MRB find RI's program to be adequate to protect public health and safety.

The MRB meeting to consider the RI report is scheduled for **June 15, at 3:00-4:30 pm, in One White Flint North, Room O-3-B-4**. In accordance with Management Directive 5.6, the meeting is open to the public. The agenda for the meeting is attached (Attachment 3).
