PROGRAM SCOPE

The licensee is a asphalt paving and engineering firm located in Zanesville, Ohio. They perform soil density and asphalt testing in Ohio, Michigan and West Virginia. The licensee has twenty Troxler 3440 series gauges. The gauges are normally stored at licensee's facility or at the project office for temporary job sites. For use at temporary job sites, the gauges are stored in locked construction trailers. The licensee does not performed any service or maintenance activities on the gauges. The licensee employees sixty gauge users who have completed the manufacturers training.

Performance Observations

Licensee described procedures used at a temporary jobsite since no such jobsite was available at the time of this inspection. Interviews of licensee personnel indicated an adequate level of knowledge of radiation safety.

Independent surveys of the gauge storage area indicated minimal results. Licensee personnel are badged. The results for 2004 had no personnel exceeding 100 mRem for the year. Licensee does not perform any work on the gauge themselves. All such work is contracted to a licensed entity.
