It is requested that the Office of State and Tribal Programs notify the Agreement States to make distribution of the final rule to their licensees. The rule will modify the Part 170 fees currently assessed to those Agreement State licensees who perform work in non-Agreement States under the reciprocity provisions of §150.20. The reciprocity fee will increase from \$1,500 to \$1,800 under the FY 2005 final rule.
