In accordance with NRC Regulatory Issue Summary (RIS) 2004-17: Revised Decay-In-Storage Provisions for the Storage of Radioactive Waste Containing Byproduct Material (<http://www.nrc.gov/reading-rm/doc-collections/gen-comm/reg-issues/2004/ri200417.pdf>), License Nos. 24-04206-15MD, -17MD, -19MD and -22MD have been modified. Each license now contains a revised decay-in-storage (DIS) condition. This revised condition permits greater flexibility for DIS of waste by eliminating a specific holding period prior to disposal.
