Gentlemen:

In Reference 1 TXU Generation Company LP (TXU Power) submitted proposed changes to Technical Specification 3.7.10 entitled "Control Room Emergency Filtration / Pressurization System (CREFS)" to add conditions for an inoperable Control Room Boundary. Based on conversations with the NRC Staff, TXU Power submitted License Amendment Request 04-05, Supplement 1, by Reference 2. This was intended to supersede the original submittal of Reference 1.

Based on further conversation with the NRC Staff, it has come to our attention that new TAC NOS MC6637 and MC6638 were opened in response to the Reference 2 submittal. By this letter, TXU Power is requesting that the original (Reference 1) submittal be withdrawn and TAC NOS. MC3956 and MC3957 be closed. The changes submitted by Reference 2 (TAC NOS. MC6637 and MC6638) are still needed for the Turbine Generator Protection System Digital Modification during the eleventh refueling outage for Unit 1 (1RF11) which is currently scheduled to start in October 2005.
