


The purpose of this modification is to: (1) confirm verbal authorization provided to you on March 31, 2005, as referenced by e-mail from Heriberto Colon dated April 1, 2005, to allow for continuation of work required to complete the drug testing portion and other enhancements to the Integrated Personnel Security System (IPSS), pursuant with the attached Statement of Work and PEC Solution's technical proposal dated March 29, 2005. As a result of this action, the delivery order ceiling and obligation amounts are increased by \$41,058.34 from 509,208.23 to \$550,266.57, and (2) extend the delivery order period of performance through September 30, 2005.

Accordingly, the following changes are hereby made:

1. Section C, "STATEMENT OF WORK," Task 4.4, entitled, "Perform Enhancements on IPSS," as reflected under Modification No. 3, is modified to incorporate the attached description of enhancements (Attachment No.1).

2. Section D.9, "PERIOD OF PERFORMANCE," is deleted in its entirety and substituted with the following in lieu thereof:

"This order shall be effective from September 30, 2002, through September 30, 2005."

3. Section D.10, "CONSIDERATION AND OBLIGATION," is deleted in its entirety and substituted with the following in lieu thereof:

"The total estimated amount (ceiling) of this delivery order is \$550,266.57."

The amount presently obligated with respect to this delivery order is \$550,266.57. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this delivery order. The obligated amount shall, at no time, exceed the order ceiling as specified above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this delivery order. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."

Task 4.4a - Other Enhancements on IPSS

Description of Enhancement:	
1.	Change order of the drug test results displayed in the drop down menu and have results default to negative.
2.	Increase the percentage of primary candidates selected for the random drug testing pool. (Discuss how the current percentage is calculated and what percentage is used to obtain random sampling, the numbers seem too high.)
3.	Add a number (in sequential order) beside the employee's name when the box beside the name is checked (indicating the employee has been selected for random drug testing).
4.	Provide 30 additional generic report templates (10 for each major section). This includes 3 reports for each section with date parameters..
5.	There is no data in the 'Random Test Period' and 'Random Test Year' fields (possible data conversion issue).
6.	Display the names of the remote sites on the screens, not the site code numbers
7.	The City of Birth and State of Birth do not display on the employee's personal data screen in the drug testing section.
8.	Provide the capability to change percentage variable for random drug testing.
9.	Add DOB field to Random Pool screens.
10.	Change link name for Drug Testing Pool reports.; Reports 39, 44, 46, and 50 are not linked into the application.
11.	Add Remarks box to Drug Testing history screens.
12.	Display dates in chronological order, with the last action reflected at the top (In drug testing, personnel security, and badging sections).
13.	Have cursors automatically appear in the first box on screens, when a user has to input data.
14.	Automatic hyphens appear when entering social security numbers.
15.	Remove the mandatory requirement for the 'Access Status Date' field (currently on Parking Lot).
16.	Support the Random Certification conducted by NRC (currently on Parking Lot).
17.	Data conversion of Drug Testing data, from the existing systems into the IPSS (currently on Parking Lot).
18.	Provide 5 to 10 hours technical support for Karen Cudd/Mary Denney (currently on Parking Lot).
19.	A mechanism to identify a certain group of licensee employees that we grant security clearances (possibly a box that can be checked (like you did for COOP/COG). New field is IAAP.
20.	Reinvestigation Notifications - If multiple investigations are reflected in the Investigations history table, in order to prevent the Reinvestigation Notifications from generating a reinvestigation notification from the last Date of Investigation entered, it will be necessary to use the 'Date To Agency,' field, that is greater than the last Date of Investigation reflected.
21.	First Name/Last Name validation. If any new person's name matches an existing applicant, the system will display any results and should prompt the user and allow the user to proceed or cancel.
22.	Create an "original view" of the Access Authorization table to map the original field names to the current/changed names.
