The purpose of this modification is to obligate FY'05 funds in the amount of \$37,000.00, thereby increasing the obligated amount of the subject task order from \$50,000.00 to \$87,000.00.

Accordingly, the following change is hereby made:

The fifth paragraph of the definitization letter dated, September 30, 2003, is deleted in its entirety and substituted with the following in lieu thereof:

"The amount presently obligated with respect to this task order is \$87,000.00. The obligated amount shall, at no time, exceed the task order cost ceiling of \$87,060.89, for the two year period. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this task order. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's risk."

A summary of obligations for this task order from award date through the date of this action is given below:

This modification obligates FY'05 funds in the amount of \$37,000.00.
