14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to (1) obligate \$5,659.37 for a remaining utility bill, and (2) increase the ceiling and obligated amount under the subject contract. Accordingly, the contract is hereby modified as follows: (1) Section B.9 - CONSIDERATION AND OBLIGATION - DELIVERY ORDERS FOR REIMBURSABLE CONTRACT SERVICES (SECTION B.5), the second sentence of Paragraph B is deleted and substituted with the following sentence: "The amount presently obligated with respect to utility services that are discussed under Section C.2.6 of this contract is \$2,090,659.30" and (2) Section B.10, CONTRACT CEILING AND OBLIGATION, the second and third sentences are revised as follows: "The total amount is increased by \$5,659.37 from \$4,769,530 to \$4,775,189.30. The total current obligations for performance of services required during the Base Year Period and OY1 is increased by \$5,659.37 from \$4,240,720 to \$4,246,379.30."
