

The purpose of this modification is to: 1) exercise the option year, thereby extending the period of performance and increasing the total estimated amount (ceiling) for performance of the subject contract from \$157,940.00 by \$127,940.00 to \$285,880.00, and 2) provide incremental funding in the amount of \$35,970.00.

Accordingly, the following changes are hereby made:

1. Section B.2 - Duration of Contract Period, is hereby deleted in its entirety and substituted in lieu thereof the following:

**"DURATION OF CONTRACT PERIOD**

The ordering period for this contract shall commence on the effective date of this contract and will expire on April 13, 2006. The term of this contract may be extended at the option of the Government for an additional 3 one year options."
